

## INTENT TO REGISTER FORM SUMMER 2022

This form is used to determine your interest in attending Summer School prior to registration/enrollment to determine your eligibility for federal student aid. Federal loans are subject to annual and aggregate maximums, and to be eligible you must enroll in a minimum of (6) hours. Therefore, the amount you borrowed, if any, during the 2021-2022 academic year as well as in prior years could affect your eligibility for loans during the summer. Federal Pell Grant may be available to eligible students who enroll in at least (6) hours. If you enroll in Summer I and intend to enroll for Summer II you must register for all classes you plan to take by June 1, 2022, in order for the classes to be considered in determining your federal financial aid eligibility for both Summer I & Summer II combined.
