The LIR Nominating Committee Recommends New Board Members

The terms of four LIR Board members will expire on December 31, 2020. We would like to thank each of these members for their service to our organization over the past several years: Bill Gerling, Evelyn Hancock, Scott Sellner, and Becky Washburn.

President Steve Buchholz appointed a nominating committee to recommend replacements for these four individuals. The committee would like to recommend the following members to serve on the LIR Board for a three-year term beginning January 1, 2021, and ending December 31, 2023.

Bill Gerling is finishing his first three-year term and is eligible to serve a second three-year term. Bill was born and raised in Cole County, attended St. Peter's Elementary and Helias High School. He has a B.S. in Social Studies Education and taught at Jefferson City High School for 30 years. After retiring from the high school, Bill worked for the Department of Elementary and Secondary Education for 16 years as the Director of Social Studies Education. Bill recently married his wife, Paula. Their children, step-children and grandchildren are an important part of their lives.

Chris Straub has been nominated to serve his first three-year term. Chris has a doctorate in school administration. He has been involved with several professional and civic organizations. He was a chemistry and physics teacher in Union, Missouri, before becoming a superintendent of schools in Union, Hannibal, and Jefferson City. After retiring from school administration, he served as a lobbyist and school finance consultant for several state educational organizations and served as an adjunct faculty member for several universities.

Lee Bunch has been nominated to serve her first three-year term. Dr. Lela Kosteck Bunch (Lee) holds a Ph.D. in School Psychology from the University of Missouri—Columbia. She has diverse experiences in school counseling at the elementary, secondary, and graduate level. She retired as the Executive Director of the Missouri School Counselor Association (MSCA). Prior to that role, she served as an assistant professor on the graduate faculty of the Division of Counseling and Family Therapy at the University of Missouri—St. Louis. She has also served as the Director of Guidance and Counseling

for the Missouri Department of Elementary and Secondary Education and on many other boards. She is currently serving on the Center for Credentialing and Education (CCE) Board as the Chair. She is also active in many community groups, including the LIR Travel Committee.

Linda Lanning has been nominated to serve her first three-year term. Linda and her husband, Chuck, had a busy commercial and residential real estate office in Watertown, South Dakota. Linda did a lot of title work and really enjoyed the research and clearing up title problems in conjunction with their attorney. (This was before title insurance, and they had to work with abstracts.) So they planned that she would go to law school and get her law degree. But Chuck was diagnosed with cancer and after a long battle, he passed away in 1986. Linda went on to get her law license and moved south to Jefferson City in 1991. She made Jefferson City her home and decided to stay even after she retired. Her children live all over the country, but she has made many friends here who are much like family.

We thank each of these individuals for agreeing to serve the organization as members of the board and humbly request your approval of this group of candidates. Normally the LIR general membership is asked to approve the slate of candidates at the Summer Membership Meeting; however, due to COVID-19, that meeting will not be held this summer.

WHAT'S GOING ON WITH LIR TRAVEL?

What an unprecedented time we are living through! We have missed traveling with our LIR friends, and I know many of you have missed the opportunity to be with friends, learn new things, and just be out and about.

Later in July, we'll begin our planning for the first half of 2021. As I'm writing this, we are still uncertain as to how the pandemic will impact what we can offer. Most of us feel that it would be good if we could provide some activities.

HOWEVER, it might look significantly different from what we've done before. Our main goal is for everyone to stay as safe and healthy as possible.

With that in mind, here are some initial thoughts, but nothing is definite at this time. We may start out next spring SLOWLY and proceed in stages. We could possibly offer a limited number of local "trips" where people could drive on their own, eliminating the need to be on a coach with 40-45 other people. The size of a group might be limited to 15-20, but the trip could be offered several times if there is interest. We would practice social distancing (as much as possible) and have hand sanitizer available. Water, packaged snacks, or possibly a box lunch would be offered, depending on the venue.

Then, after evaluating how that went and the status of the COVID-19 situation, for the last half of 2021, we could begin offering day trips using some of the trip itineraries that we were not able to use this year. This would require riding on a coach, probably eating at a restaurant, and being with a group, but wouldn't entail staying overnight at a hotel or riding for longer distances.

There still is the possibility of attending the Capital City Productions' showing of "Give 'Em Hell Harry, Saturday, November 7. If it seems they are following state and city guidelines, we may be able to go. We will put out an email to let you know how that will be handled.

MISCELLANEOUS COURSE INFORMATION

Registration forms are provided in the LIR newsletter or on the LIR web site. Each course is \$12 unless otherwise noted. Most courses have four two-hour class sessions.

A few two-hour free courses are also offered, but registration is required for these as well so adequate seating is available and presenters know how many handouts or other course materials are needed.

Registration should be mailed to the LIR office.

- Location of courses varies, depending on the topic and class size. Specific locations for each class are named in this newsletter **or** will be announced in the notification letter you receive. Location changes will also be indicated in the notification letter.
- Your reminder notification will be **emailed** unless circumstances require USPS mailing.
- Please contact the course coordinator or LIR office if you cannot attend **any** session -- free or paid.

If you must cancel a course for which you have enrolled, the registration fee may be refunded if the LIR office (681-6152) receives notice one week prior to the start date of the first class. Refunds are processed after the course is completed.

After the deadline, should an emergency occur that prevents you from attending the course, the LIR office should be notified as soon as possible.

Refunds will be considered on a case-by-case basis by the curriculum chair and the office manager.

POTPOURRI OF COLE COUNTY/ MISSOURI HISTORY Part 2

Celebrating the Bicentennials of Cole County (2020) and Missouri (2021) with a little of this and a little of that — Join us as various presenters offer "A Potpourri of Cole County/Missouri History."

Session one: September 2: Missouri's Governor's Mansion, built 150 years ago in 1870, represents the proud development of the state through an imposing Victorian Mansion with elegant rooms and furnishings. We shall view these historic rooms but also learn how the Friends of the Missouri Governor's Mansion works to preserve this fascinating building and its history.

Then we'll go across the street to the Cole County Historical Society Museum to view the many exhibits of Cole County history AND learn how the Society works to preserve our heritage.

Session two: September 9: Anna Knaebel will welcome us to St. Francis Xavier Parish, Taos. This class is the history and story of Father Helias. You will hear a brief history of St. Francis church which displays a famous painting donated by the Countess of Lens, mother of the saintly priest. The small memorial chapel and tomb of Father Helias is also at the entrance of the church. A museum holding memorabilia of Father Helias, priests, and other people of interest in the area is located in the church basement.

Session three: September 26: Doris Keeven-Franke, Executive Director of the Missouri German Consortium, author, writer, and public historian from St. Charles is the speaker. German Abolitionists and the Underground Railroad is the topic. After facing oppression and severe hardships, German immigrants would take the American ideals of freedom and liberty for all literally. During the Civil War, they would take a strong stance for Lincoln and the Union Army. They would be loud in their fight against slavery and work hard to promote emancipation, as the ideals found in the Constitution. Besides their attacks on slavery in the press, they would also give refuge to those seeking freedom, providing safe "stops" on the Underground Railroad, turning wine cellars and church pulpits into safe places, as they were "conductors" on the road to freedom.

Session four: September 23: Sam Bushman, unofficial Cole County historian and Presiding Commissioner of Cole County will share how some of our smaller Cole County communities were founded. Sean Ross of the State Historical Society of Missouri will share his research on Prohibition AND the Ku Klux Klan in Missouri.

August of 2020 marks the 100th anniversary of the 19th amendment and women's right to vote: an 85-year struggle that began with Susan B. Anthony and Elizabeth Stanton in the 1830s. This four-part series will look at this history and current issues surrounding the right to vote as we head into the 2020 general elections.

October 7 Women's Struggle for the Vote. In 1916, thousands of women wearing white and carrying yellow parasols lined the streets

of St. Louis demonstrating for their right to vote. The protest became known as the Golden Lane. Fulton author Margot McMillen will discuss this historic struggle in Missouri. Marilyn McLeod with the League of Women's Voters will discuss the national women's suffrage movement.

October 14 State and Local Voting Procedures. Chrissy Peters, Election Officer with the Secretary of State's Office, and Steve Korsmeyer, Cole County clerk, will discuss State and Local voting procedures.

October 21 The Laws Governing the Right to Vote. Attorney Anthony Simones, Director of Citizenship Education with the Missouri Bar Association, will discuss the constitutional amendments pertaining to the right to vote.

October 28 History of the Right to Vote. LU professor Dr. Amy Gossett will discuss the evolution of the right to vote from 1776 to the present. Current issues of voter suppression, voter fraud, and Russian meddling will also be discussed.

In Memoriam

Learning-in-Retirement's founder, Dr. Gary Scott, recently passed away. Without him, Learning in Retirement would not exist.

Dr. Scott had read about organizations that offered educational courses for older people when those people did not want to stop learning as they aged. He attended an Elderhostel meeting in Kansas City, returned to Lincoln, and began to talk to retired people in the community about the feasibility of establishing an Institute for Learning in Retirement in Jefferson City.

Because Lincoln University had curriculum available, Dr. Scott asked LU if it would provide the facilities and some support to get a program off the ground that would offer educational short courses to retired members of the community. Then LU President Dr. Wendell Rayburn agreed, and June Glaser, who was an Associate Professor of Research Instruction at LU and chair of the LU Campus Gerontology Committee, joined Dr. Scott in forming the Jefferson City area Learning in Retirement organization.

Learning in Retirement has become an important part of many retirees lives in the JC area, with membership ranging from 380 to 420 people from all walks of life who want to continue to learn. But, LIR offers more than the original short courses, ranging from one-to-five-day trips; clubs offering card games, word games, physical exercise, reading and writing groups, music, drawing, and sewing. The organization is also open to new ventures suggested by members to keep bodies and brains active.

However, the most important aspect of being a member of Learning in Retirement is the social interaction. Every member, when interviewed, says the friends they have made is the best part of being a member of this organization.
