- Recover refrigerant in circuit and reuse after compressor is evacuated
- Set up rigging with the use of a crane, remove damaged compressor and replace with rebuilt compressor
- Add oil using OEM York oil type L.
- Inspect and secure all high voltage wiring
- Replace refrigerant core driers
- Pressurize with dry nitrogen, leak test, and evacuate system to 500 microns
- Startup and check system for proper operation
- Work schedule must be coordinated with Lincoln University Personnel
- Work site must be kept in safe and orderly fashion for safety of contractor employees, LU Staff and the students residing in the building.
