To all Respondents:

The above referenced Request for Proposals is hereby amended as follows:

- 1. Proposal Form, Item 9:** Is deleted in its entirety.
- 2. Affidavit for Affirmative Action:** Is deleted in its entirety and is no longer required.
- 3. Instructions to Bidders/General Specifications:**
  - In Section 10C, the following phrase is deleted: “success in achieving the specified diversity goal or demonstrating a good faith effort related thereto”
  - In Section 11C, the following phrase is deleted: “and appropriate affirmative action plan submitted”
  - Article 16 is deleted and replaced with: Article 16/RSMo. 34.074: The terms of RSMo. 34.074 apply to this RFP.
- 4. General Conditions:**
  - In the Index, Article 34 is removed from the Index listing.
  - In Article I/Definitions, the terms “MBE,” “Minority,” “Minority Business Enterprise,” “WBE,” and “Women Business Enterprise” are hereby deleted in their entirety.
  - Article 6 is deleted in its entirety and replaced with the following:

Article 6/Nondiscrimination in Employment:

The Contractor and its subcontractors will not discriminate in violation of applicable law and shall not consider race, color, sex, religion or national origin in ways that violate applicable law.
  - Section 13(A)(d) is deleted in its entirety.
  - In Section 27(A), the phrase “ten percent (5%)” is replaced by “five percent (5%)”

- In Section 27(A), the phrase “ninety percent (90%)” is replaced by “ninety-five percent (95%)”
- Section 27(B)(f) is deleted in its entirety.
- Article 34 is deleted in its entirety.

**5. LU MBWE Compliance Evaluation Form, LU MBE/WBE Eligibility Determination Form, MBWE Eligibility Determination Form for Joint Ventures, and MWBE Application for Waiver:** Are each deleted in their entirety and are no longer required.

**6. Except as expressly provided in this Addendum, the RFP remains in full force and effect, unmodified.**
