

## AFFIDAVIT FOR PROOF OF CITIZENSHIP OR ELIGIBLE NON-CITIZENSHIP STATUS

Your 2024-25 FAFSA (Free Application for Federal Student Aid) requires additional information in order to verify that you are either a citizen or national of the United States, a permanent resident of the United States, or an eligible non-citizen of the United States. You may provide proof of your eligible citizenship or immigration status in one of two options: (1) presenting original documents for photocopy and validation in person directly through the Financial Aid Office or (2) utilizing a Notary Public Official to certify the presentation and photocopy of your original documents. You may not mail, scan, or fax copies of your original documents or a valid unexpired government- issued photo identification without this signed affidavit and use of a Notary Public Official.
